CONSIDERATION/APPROVAL OF THE MINUTES OF THE SEPTEMBER 22, 2021 MEETING

ACCEPTANCE AND APPROVAL TO RELEASE FISCAL YEAR ENDING JUNE 30, 2021 UNIFORM GUIDANCE AUDIT REPORT

Rob Adams introduced the staff from Brown Edwards.

Staunton Gorrell presented the Fiscal Year Ending June 30, 2021 Uniform Guidance Audit Report. Mr. Gorrell noted that management appropriately applied government accounting standards in the Fund's financial statements. Mr. Gorrell also noted that the Fund has complied with the accounting standards in all material respects and that there have been no deficiencies or weaknesses noted.
