STATE OF WEST VIRGINIA FY2022 CONSOLIDATED ANNUAL
PERFORMANCE AND EVALUATION REPORT (CAPER) DRAFT

As required by Section 104(d) of the Housing and Community Development Act and 24 CFR Part 91.115(d), the State of West Virginia is providing an opportunity to comment on the Fiscal Year 2022 Consolidated Annual Performance and Evaluation Report (CAPER). The report is specific to the following programs: Community Development Block Grant (CDBG), CDBG CARES Act (CDBG-CV), HOME Investment Partnerships Program (HOME), Emergency Solutions Grant (ESG), Emergency Solutions Grants – CARES Act (ESG-CV), Housing Opportunities for Persons with AIDS (HOPWA), and Housing Opportunities for Persons with AIDS Care Act (HOPWA-CV) from July 1, 2022, through June 30, 2023. The 2022 CAPER is prepared by West Virginia Community Advancement and Development (WVCAD), a division of the Department of Economic Development (WVDED), and the West Virginia Housing Development Fund (WVHDF).

A review and comment period will begin on Monday, August 28th, 2023, and conclude at the close of business on Tuesday, September 12th, 2023.
